



## 2022 MARYLAND STATE MATCH PISTOL REGIONAL CHAMPIONSHIP

**Dates:** December 3 & 4, 2022; provided that additional relays may be added if the number of preregistrations warrants.

**Eligibility:** This is a CMP sanctioned match and is open to all competitors. Membership in the CMP or MSRPA is not required.

**Entries:** Competitors may preregister by using the attached Match Entry Form, accompanied by payment of the entry fee. Entry fees may be paid by a check or money order made payable to "MSRPA". Preregistration forms and entry fees must be received not later than the Wednesday preceding the match. Post entries will be accepted at the range each day until 30 minutes prior to the match start time, to the extent that firing positions remain available. This match is limited to 14 competitors per relay, and will be conducted in four relays on Saturday, December 3 and four relays on Sunday, December 4. Preregistration forms and entry fees should be mailed to John Hollingshead, PO Box 4145, Frederick, MD 21705.

**Entry Fees:** \$40.00

**Note – All match fees are waived for junior competitors who are accompanied by a parent or legal guardian.**

**Rules:** The current edition of the CMP Pistol Competition Rules will govern this match. **All guns fired during the match must be .22 caliber.**

**Classification:** The CMP classification system for match pistol competitions will be used. Individuals who have not been classified by the CMP but have an NRA precision pistol classification will compete using that classification. Individuals without either a CMP or NRA classification will compete in the master class.

**Firing Position Assignments:** At the discretion of the Match Director, firing positions may be assigned, and competitors will be notified of their firing positions when they sign in at the range on the day of the match.

**Awards:** Awards will be given to the open winners in each of the 5 matches comprising the state championship. A first place award will be given in each class for each match provided that there are at least 5 competitors in the class. A second place award will be given if there are at least 10 competitors in the class, and a third place award will be given if there are at least 15 competitors in the class. Awards will be mailed to winners by check or cash.

**Team Matches:** Team matches will be held on Saturday and Sunday at noon. These matches will be open to 4-person teams, and the course of fire will be the National Match Course. Only .22 caliber pistols may be used. Targets fired in the team matches will be scored by match officials. The fee for team matches will be \$20 per team. Captains of teams wishing to compete should contact the match director at the email address below to reserve firing positions.

**Starting Time of Relays:** The championship match is a 900 aggregate, with 4 relays fired on Saturday, December 4 and four relays fired on Sunday, December 5. Firing will commence each day for the first relay at 8:00 AM, the second relay at 10 AM, the third relay at 1 PM, and the fourth relay at 3 PM.

**Match Schedule:**

Each relay will consist of the following matches:

**Scoring:** All scoring will be done by competitors immediately after the end of their relay. Upon completion of each relay, the Chief Range Officer will distribute scorecards and fired targets to the competitors, and each competitor will score all targets for the competitor to their right, except that the competitor on highest firing position used will score the targets for the competitor on the lowest position used. **Each competitor must remain after his relay is completed to score targets for his relay and complete the corresponding score card before leaving the range.** A challenge fee of \$1.00 will be charged for each challenge as to the score of a target. A 3-person jury designated by the Chief Range Officer will render final decisions on any challenge.

**Match Conditions:** All firing will be done indoors at 50 feet, using B-2 slow fire targets and B-3 sustained fire targets. Competitors must provide and wear eye and ear protection. Violations of CMP or club rules, or good safety practices, will result in the competitor's removal from the range and forfeiture of fees. Food will be available for an additional charge.

**Directions to the Range:** This match will be conducted at the York & Adams Game & Fish Association indoor pistol range at 413 Country Club Road, Abbottstown, PA. Abbottstown is located at the intersection of Routes 194 and 30. The YAGFA pistol range is one mile south of Abbottstown. From the traffic circle in the center of Abbottstown, proceed 1/4 mile east on Route 30 and turn right on Country Club Road. Follow Country Club Road approximately one mile to the range on the left.
